TERMS AND CONDITIONS OF COMPETITION 1/2

- Minimum age: 18 years (age 16 and up only with signature of parent or guardian)
- Signed medical certificate (English or German) issued by a physician authorized by law certifying that there are no counter indications to the practice of freediving, date of examination must be at most 365 days (1 year) before last competition day. We recommend the use of the official A.I.D.A medical form which can be found here.
- Each athlete must be member of A.I.D.A. International i.e. your local A.I.D.A. Association. Ensure you are registered on the **website** (www.aidainternational.org).
- Participation fee for A.I.D.A members is
 - o Early eel: 65 € (payment until 31st December 2024)
 - o Regular ray: 75 € (payment until 31st January 2025)
 - o Lazy lobster: 85 € (payment until 8th February 2025)
- Only coated weights are allowed in the swimming pool. This will be checked during registration.
- Participation fee needs to be transferred until February 8th, 2025, otherwise the registration is not valid.
- If a participant does not appear for the competition their paid entry fee forfeits. Refund is not possible.
- The official language of this competition is English.
- You agree to be filmed and photographed during the whole competition, and if photos and videos are published, you will not be asking for financial compensation.
 Competition organizer is obligated not to publish captured images and videos out of context of freediving. Competition organizer is obligated to use the images and videos for the purpose of popularization and education of freediving. Competition organizer is obligated to keep footage and films away from unauthorized use.
- Photo and video recordings are property of the organizer and will not be handed over.
